



As reported in in the Lubber's Line last year, a market study was completed by America's Boating Club, (ABC) formerly, United States Power Squadrons (USPS).

The results, not surprising, found that USPS, who has been doing business the same way for 100 years, was viewed as being stogy and out of touch. Times have changed. Today's boaters are more diverse, with different interests and less time devoted to boating activities. Families are busier. 

## It is Time to Send Me Your Merit Mark Info

In September, I will be sending out an email message asking for your Merit Mark Log to support a request to award our Squadron members a Merit Mark from the USPS Commander. Merit Marks are our "pay" for the support you have given our Squadron throughout 2021. Twenty-five or more and you don't pay any dues for

Each member is responsible for submitting supporting information to me so I can prepare the recommendation. The Merit Mark Log is simple: a list of each activity and how many hours you spent each activity for the period starting on January 1, 2021 and ending October 8<sup>th</sup>, 2021. Just email it to me at 108atkin@gmail.com by October 15<sup>th</sup>. If you prefer, you can snail mail me at 108 Tall Pines Road, Newark, DE 19713.

A minimum of 16 hours for the year, or 10 vessel safety checks per person are required to be considered for an award.

Here are some suggestions:

- Attending a general meeting only counts if you present something to the membership. Note what it was and how much time was involved.
- If you worked on an activity but it was shut down by COVID, it still counts! For example, work on the Crab Feast comes to mind.
- Note the number of committee meetings you attended, what your contribution was and how much time you spent on that activity.
- If you have taught or proctored a course, tell me the name of the course and number of sessions. If you provided a special service for the class (grading tests, mentoring students, etc.), what was it, how many times and time spent.
- For vessel safety checks, at least 10 per person per year are needed. However, also note if you organized an event, how long you drove to the event, or if you provided any additional services or advice, how much time was spent.
- If you supported an outreach event, what did you do, when was it, and how many hours did you spend at that event supporting it?
- For membership recruitment, identify how you promoted the squadron, what your success was, and how much time you spent on that activity.
- If you wrote an article for the Lubber's Line, what was it on, how long did it take to write, did you take pictures to go with it?
- If you found speakers for our programs, which date was the program, and how much time did you spend to source each speaker?
- If you coordinated our ZOOM meetings, or supported setting them up, etc., how much time do you spend for each meeting and how many meetings did you support?
- If you are on the Assemblies, Cruise or Marketing Committee, for example, detail what you did, how much time, etc.

#### And there are so many more ideas like these!

My log would look like this so far: Attended X Executive Committee Meetings at 2 hours each, total Y. Wrote 2 articles for Lubber's Line promoting Merit Marks, 3 hours total. Designed new boater's certification course cards, 8 hours total. Prepared boater's course cards for distribution at National Guard class, 1 hour total. Prepared monthly membership reports for 10 months, 1 hour per report, total 10 hours. Prepared and submitted Merit Marks to USPS Commander, hours TBE.

Now that wasn't bad, was it? It took 5 minutes out of my day.

Please work on your logs now and remember to send them to me by October 15<sup>th</sup>.

Don't worry, I will remind you!

### A New Law Requiring the Use of Engine Cut-off Switches

Operators of recreational vessels less than 26 feet in length will be required to use an engine cut-off switch (ECOS) and associated ECOS link (ECOSL) as of April 1, 2021, as the U.S. Coast Guard implements a law passed by Congress.

The ECOS and ECOSL prevent runaway vessels and the threats they pose. The ECOSL attaches the vessel operator to a switch that shuts off the engine if the operator is displaced from the helm. The ECOSL is usually a lanyard-style cord that attaches to an ECOS either in close proximity to the helm or on the outboard motor itself if the vessel is operated by a tiller. When enough tension is applied, the ECOSL disengages from the ECOS and the motor is automatically shut down. Wireless ECOS have recently been developed and are also approved for use. These devices use an electronic "fob" that is carried by the operator and senses when it is submerged in water, activating the ECOS and turning the engine off. Wireless devices are available on the aftermarket and are beginning to become available as manufacturer-installed options.

Each year, the Coast Guard receives reports of recreational vessel operators who fall off or are suddenly and unexpectedly thrown out of their boat. These events have led to injuries and deaths. During these incidents the boat continues to operate with no one in control of the vessel, leaving the operator stranded in the water as the boat continues on course, or the boat begins to circle the person in the water eventually striking them, often with the propeller. These dangerous runaway vessel situations put the ejected operator, other users of the waterway, marine law enforcement officers, and other first responders in serious danger.

Section 503 of the Coast Guard Authorization Act of 2018 required manufacturers of covered recreational vessels (less than 26 feet in length, with an engine capable of 115 lbs. or more of static thrust) to equip the vessel with an ECOS installed as of December 2019. Owners of recreational vessels produced after December 2019 are required to maintain the ECOS on their vessel in a serviceable condition. It is recommended that recreational vessel owners regularly check their existing ECOS system to ensure it works properly, following manufacturer's instructions.

Section 8316 of the Elijah E. Cummings Coast Guard Authorization Act of 2020 requires individuals operating covered recreational vessels (less than 26 feet in length, with an engine capable of 115 lbs. or more of static thrust, which equates to about 3 horsepower or more) to use ECOS "links" while operating on plane or above displacement speed. Using the ECOSL is not required when the main helm is installed within an enclosed cabin. Common situations where ECOSL use would not be required include docking/trailering, trolling, and operating in no-wake zones.

Seven states currently have ECOS use laws for recreational vessels, and 44 states have ECOS use laws for personal watercraft (PWC).

## Boater Safety Education is Back

On July 13<sup>th</sup> the squadron resumed basic boater education for the first time in more than two years and restores a partnership with the Delaware Safety Council for boating education. Seven members of the Delaware National Guard attended the class at the Delaware Safety Council office in New Castle. It is the second time the squadron has been requested to offer a class by the safety officer for the Delaware National Guard.



The opportunity was a bit of a surprise as the safety officer contacted the Safety Council which had accommodated the first class to ask for a class. In turn, the Safety Council class coordinator, called us to see if we could provide a class and we said that we would be happy to be back in the education business. The class administrator P/C Mark Atkinson, AP began to organize a class.

The first step at the end of May was to check the Delaware Fish and Wildlife Boating website class calendar



and there were no classes listed. He called the Office of Boating Safety to find out if the state would support a class with books, tokens and processing the exams. The initial response was that the state was still adhering to a policy of no public classes.

After he explained this would be a closed group offered to members of the Guard and not publicized on the state website it would be supported. The director of the state office even offered to send a fish and wildlife officer to

meet the class and talk about boating law enforcement.

Dates for three sessions were finally set in July to accommodate everybody's schedules. P/C David Sharpless, AP and P/C John Koval, P volunteered to instruct the course, while Delaware Fish & Wildlife Officer Bryan Wittington visited to congratulate the class on the last meeting night.

As with the previous "Guard" class, the students were enthusiastic, attentive, and disciplined. There were two couples who are current active boaters who needed certification, one who rents boats on occasion and wants certification and to have more knowledge, and two who are thinking about getting into boating.

The squadron is now looking forward to re-establishing a partnership with the Delaware Safety Council for classes as we were invited to present three boater certification classes in 2022. The Council had offered classes in the past but lost their instructor several years ago. We wanted to offer classes but needed a space. The council will also raise the visibility of our classes with its means of publicity. P/C David Sharpless and P/C Mark Atkinson had met with Executive Director Pete Booker a year and a half ago about a partnership. In between the COVID 19 pandemic struck and all our plans were derailed.

## Instructor Development

A class to prepare members to teach public courses!

Where: A blended virtual on-line & live program.
On-line via Zoom. Live classes available in

When: On-line classes begin October 14, 2021 Live sessions begin on November 11

Most USPS members must complete the Instructor Development (ID) course to become certified to teach the public. This special 2021 class offers an expedited program for members who have not been able to attend a local class.

This is a two-phase class.

**Phase 1** provides on-line tutorials of the USPS Instructor Development course materials.

Phase 2 provides live sessions where students can complete the required 5-, 10- & 15-minute presentations.

The Instructor Development course is designed to demonstrate interactive teaching methods focused on adult learning. Students are required give three presentations to their peers utilizing a variety of teaching aids and presentation skills; and prepare a 1-hour lesson plan that's submitted to USPS for review.

ID course details are available on-line at <a href="https://www.usps.org/departments/13000/13000-educational-committees/13290/13290-instructor-development-course">https://www.usps.org/departments/13000/13000-educational-committees/13290/13290-instructor-development-course</a>. Prior to beginning class students must download materials from this site and review class requirements.

This special class is organized to serve many.

USPS members. The required 8 session curriculum (**Phase 1**) is presented on-line using the Zoom application. Many members may participate.

Students who complete the 8 sessions must then (**Phase 2**) present the 3 required presentations to a live audience and then prepare the 1-hour lesson plan. Two venues are available:

A centrally organized **Phase 2** program will be conducted during the USPS District 5 Educational Conference in Lancaster PA. Student seats are limited by resources and available time.

Students who cannot participate in Lancaster must coordinate with local officers to complete **Phase 2**. A course template to support local officers and instructors will be provided.

The Lancaster PA schedule details are evolving. Facility resources are available on November 11 to support several simultaneous sessions. Instructor availability will limit the number of sessions and student seats. An equitable method of allocating seats to squadrons will be developed.

Required for USPS members who desire to teach public boating safety classes. Students completing the program become USPS Certified Instructors for a 4-year period. Registration required! Contact Nancy Cheris or the D5 DEO/ADEO for details.
